End User Agreement – TALC Database

Access to the database has to be requested for every single project in which TALC data are intended to be used.

With database, we denote both the actual data as well as the interface to the database. The access to the database will be granted for one year. Reapplication for continuing use is necessary.

If at any point, the administrators of TALC database have a reasonable doubt that the user does not act in accordance to this agreement, he/she will be notified of this and will immediately be declined the access to the database. All copies of TALC database data must be deleted.

By signing this document, the user, he or she who will make use of the TALC database agrees to the following terms.

Responsibility

A person with a permanent position at an academic institute must sign this document (the authorized official signee, preferred position: professor). Other researchers (users) affiliated with the same project and institute for whom the signee is responsible may be named at the end of this document. This will allow them also to work with this dataset. Additional users affiliated with the same project and institute may be added later in written form.

Data use

The TALC database contents may only be used for civil and academic research. Non-academic purposes include, but are not limited to:

- creating military or intelligence applications
- using the data in advertisements
- developing governmental systems used in public spaces
- selling data from the TALC datasets
- proving the efficiency of commercial systems
- training or testing of commercial systems

Distribution

The user may not distribute the database or portions of the data in any way, with the exception of using the data for the illustrative purpose in academic publications or presentations. Note that publications will have to comply with the terms stated below.
